2.Scope ofwork

Engaging Mini Excavator hire basis for one year for sanitation, Engineering and town planning works in Ramagundam Municipal Corporation

- The Scope of work includes, Providing / Engaging MiniExcavator on hire basis with driver, helper with fuel and other lubricants etc., to run for the works in sanitation, Engineering and town planning works in Ramagundam Municipal Corporation.
- The Agency / Firm, whois willing to provide the said machine to RMC, shall provide the below mentioned services under the scope of work for Providing / Engaging Mini Excavator on hire basis with driver, helper with fuel and other lubricants etc., to run for the works in sanitation, Engineering and town planning works in Ramagundam municipal corporation.
 - I. Providing / Engaging Mini Excavator on hire basis with driver, helper with fuel and other lubricants etc., for working daily 8 hours and 6 days in a week for a period of one year.

3. Eligibility Criteria

- The applicant should have a registration of Agency / Firm and submit a valid proof for registration.
- The applicant should have Own vehicle of Mini Excavator and produce vehicle documents or the
 applicant should produce valid lease document if leased vehicle for this purpose from owner of
 the said machine along with all valid vehicle documents for one year.
- Preference will be given to the latest and conditioned vehicles. Vehicle should be function as per the RTA conditions.
- .The applicant should also have GST registration certificate and a copy of same also to be submitted with the application.
- The applicant should have valid PAN No.

4.PostEvaluation:

- After Scrutiny and verification of applications the successful Agencies /firms shall receive a confirmation e-mail from Ramagundam MunicipalCorporation.
- All Agencies / firms shall present their applications to the RMC-Officials along with Quotations / financial proposal by the interested parties, RMC shall review and take decision and shortlist the Agencies / firms and the successful party shall be issued with aLoA to conclude agreement to Providing / Engaging Mini Excavator on hire basis.
